___ Dues commence upon acceptance by the Board of Governors.

___ Initial dues payment is to be made by check or money order or through our 3rd party credit card processing company and is required upon submitting an application for approval.

___ All dues are payable upon receipt of member statement. Dues are billed in 8 installments from September through April for the entire membership. Upon membership approval, installments billed prior to your acceptance date are due in full. The remainder of the dues balance will be billed according to the installment billing schedule beginning the month membership is approved. Dues payments must be current before playing privileges will be extended in the spring. If scheduled payments are not received by the last day of the month, interest will be charged at 1.5% per month.

___ Upon date of membership approval, access to the club will be granted. All memberships begin on the first day of our fiscal year, October 1 and automatically renew on September 30 of each year. The new golf season starts on October 1 of each year and ends on September 30 of each year. If a member resigns on September 30, golf privileges will also cease on September 30. Once a member resigns from the club all access as a member will cease on the date of resignation.

___ Food minimums start upon acceptance. \$60 food minimum per month for each membership. Last names A-K food minimum will be calculated on the 1st of the month to the last day of the month 30th or 31st. Last names L-Z food minimum will be calculated on the 15th of each month to the 16th of the following month. \$120 food minimum per 4 week period for Limited Memberships.

___ In September of 2014 the Board established a capital dues assessment. These funds are used for capital improvements for the club. 2020-2021 assessments are \$300 per year for Golfing members and \$70 per year for House members. This will be billed in three equal assessments in the months of April, June and August 2021. Youth Golf & Limited Time memberships are exempt from Capital Assessments for the 2020-2021 season.

___ If admitted to membership, I agree to be bound by the By-Laws and Regulations of Purpoodock Club during such Membership. I understand that failure to pay dues or other charges in accordance with the terms set forth in the enclosed Regulations, which I have read, will be sufficient cause to terminate my Membership.

___ I give permission to Purpoodock Club to check any references necessary for the acceptance of my application.
