

PURPOODOCK CLUB
MEMBERSHIP CLASSIFICATIONS – DUES STRUCTURE & PAYMENT SCHEDULE
October 1, 2020 – September 30, 2021

All dues are payable upon receipt of member statement. **All memberships and dues schedule run fiscally.** Dues are billed in 8 installments from September through April for the entire membership. Upon membership approval, installments billed prior to your acceptance date are due in full. The remainder of the dues balance will be billed according to the installment billing schedule beginning the month membership is approved. Dues payments must be current before playing privileges will be extended in the spring. If scheduled payments are not received by the last day of the month, interest will be charged at 1.5% per month. A member can accelerate the above payment schedule at any time. VOTING GOLF MEMBERSHIPS

GOLF FAMILY

Entitles you and your family to all activities of the club. The membership holder is the "Voting Member". Members of a Family, Associate Family & Junior Associate Family memberships do not pay green fees. Children or grandchildren of the membership holder will be included under a family membership up to age 24. **Children over the age of 16 may play without restrictions.**

FAMILY

Dues \$5,550

Ages 40 and over. *Responsible for a \$60/month food minimum fee.*

ASSOCIATE FAMILY

Dues \$4,330

This membership is for 35–39 years old including Legacy members. *Responsible for a \$60/month food minimum fee.*

JUNIOR ASSOCIATE FAMILY

Dues \$2,780

This membership is for 18 to 34 years old including Legacy member. *No food minimums.*

GOLF SINGLE

Entitles you to all activities of the club. The membership holder is the "Voting Member". The membership holder of a Single membership does not have to pay green fees. **No restrictions on play times.**

SINGLE

Dues \$4,000

Ages 40 and over. *Responsible for a \$60/month food minimum fee.*

ASSOCIATE SINGLE

Dues \$2,980

This membership is for 35–39 years old including Legacy members. *Responsible for a \$60/month food minimum fee.*

VOTING GOLF MEMBERSHIPS

CONTINUED

JUNIOR ASSOCIATE SINGLE

Dues \$2,060

This membership is for 18 to 34 years old including Legacy members. *No food minimums.*

LEGACY

Dues \$1,650

This membership is for the sons and daughters of a family membership, up to age 34, who are no longer allowed to play as family members. Sons and daughters must apply within 1 year after reaching age 24, i.e. before reaching 25. Legacy members will receive priority over other prospective associate members.

CORPORATE MEMBERSHIP

FAMILY OR SINGLE GOLF OPTIONS

This membership shall be available to any bona fide corporation or partnership carrying on an active business apart from the Club membership. Such membership shall be comprised of three or more family or single memberships. **One of whom must be an owner, partner, officer, or director** and once this main positioned is fulfilled may also include full-time employees of the corporation. This membership entitles you (and your family) to all activities specified within the membership option of your choice. *All Corporate members are responsible for a \$60/month food minimum, per membership. No restrictions on play times.*

GOLF COURSE OPENING PREVIEW – SINGLE GOLF MEMBERSHIP

NOT AVAILABLE FOR THE 2020–2021 GOLF SEASON

Dues \$500

Duration: 6 weeks upon course opening in the spring. This membership will have access to all Dining areas, Golf Shop, range and use of locker rooms. Preview members do not pay green fees. Preview members may also participate in any tournament taking place during the 6-week period and may play during **voting golf member preferred starting times**. All charges must be paid for at the time of service via credit card. **\$500** will be credited towards the first-year dues payment if the preview member decides to stay. Membership applications must be filled out along with dues payment and sent to the Board for approval before the Preview Membership will be activated. Limited to one year. Must be 18 years old to hold a preview membership.

NON-VOTING GOLF MEMBERSHIPS

This membership entitles you to all activities of the club. Non-Voting Golf Members do not have voting rights. Members who wish to play outside of the designated playing times will pay an established green fee \$50 for 18 holes and \$30 for 9 holes, \$30 for children ages 13-18. **Cannot play during voting golf member preferred starting times.** Children or grandchildren of the membership holder will be included under a family membership up to age 24. *Responsible for a \$60/month food minimum fee. Responsible for yearly capital assessment fees.*

WEEKDAY GOLF

Entitled to unlimited play Monday - Wednesday and Thursday after 10:00 a.m. without paying greens fee. Members who wish to play outside of the designated weekday times; Fridays, Saturdays and Sundays, will pay established green fee. Weekday golf members may not enter club tournaments except for those specified in the Tournament Handbook.

TWILIGHT MEMBERSHIPS

This membership entitles you and your family to all activities of the club. Twilight members do not have voting rights. Twilight Members may play after 3:00 p.m. without paying a green fee. Members who wish to play outside of the designated twilight time, before 3:00 p.m., will pay established green fee. Twilight golf members may not enter club tournaments except for those specified in the Tournament Handbook. Starting times will be modified as the season progresses, after Labor Day starting time is 2:00 p.m. and after October 1, starting time will be 1:00 p.m. *Responsible for a \$60/month food minimum fee.*

NON-VOTING GOLF MEMBERSHIPS

LIMITED TIME MEMBERSHIP

May & October

June, July, August,

Limited Time members may join for a minimum of a 4-week increment during the months of May-October. Limited Time members **cannot play during voting golf member preferred starting times.** *Limited Time members will be responsible for a \$120/month food minimum.*

YOUTH GOLF MEMBERSHIP

Dues \$1,030

This membership is for minors ages 13-18 years old. Parents will hold a house membership for their minor child. **Parents do not have golf any privileges.** Youth Golf members do not have voting rights. **Cannot play during voting golf member preferred starting times.** Member green fee \$15.00 per day. Youth Golf Guest green fee (13-18yrs) is \$30 per day. *Responsible for a \$60/month food minimum fee.* No capital assessment fees.

DINING MEMBERSHIPS

House memberships may use the clubhouse dining areas, banquet facilities and participate in all non-golf related club events. House membership holder may play twice per month paying the guest green fee and **cannot play during voting golf member preferred starting times.** **Monday, Tuesday, Wednesday & Thursday, after 3:00 p.m. House members do not have access to the golf course on Friday, Saturdays, Sundays or Holidays.** Spouses and dependents do not have access to the golf course and will be considered a guest and held to the guest restrictions. *Responsible for a \$60/month food minimum fee. Responsible for yearly capital assessment fees.*

HOUSE

Dues \$550

HOUSE & PRACTICE TEE

Dues \$950

Gives the main membership holder full use of the range and practice facilities.

Family members do not have access to the practice areas.

Purpoodock 2020-2021 Member Green Fee

- Purpoodock Club green fees are \$50 for 18 holes and \$30 for 9 holes.
- Youth Golf members (ages 13-18) green fee is \$30 per day.

Purpoodock 2020-2021 Guest Green Fee

- Purpoodock Club 2020-2021 guest green fees are \$70 for 18 holes and \$35 for 9 holes.
- Youth Golf guests (ages 13-18) guest green fee is \$30 per day.

Guest Policy

Members must play with their guest(s). Golf members, in all golf categories, are welcomed to invite guests. Members may bring up to seven (7) guests without having the approval of the Golf Professional. All guests must play with the member, during the member's permitted playing times. **Guests cannot play during voting golf member preferred starting times.** Range access is included with the guest green fee, paying \$5 per bag of balls, guests must be visiting the golf course to use the practice facilities. The spouse or dependent of a single golfer can use the social facilities of the club and may visit the Purpoodock golf course no more than twice in a month. An individual, a non-member, may visit the Purpoodock golf course no more than twice in a month,

other than during Member Guest. Guests are not permitted to use the Practice Tee unless playing with a member on the course.

Monthly Assessments

Club assessments will also begin immediately upon acceptance.

- Memberships are responsible for a \$60/month food minimum. Junior Associate Family & Junior Associate Single are exempt from minimums.
- All Limited Time Memberships are responsible for a \$120/month food minimum.
- In September of 2014 the Board established a capital dues assessment. These funds are used for capital improvements for the club. 2020–2021 assessments are \$300 per year for Golfing members and \$70 per year for House members. This will be billed in three equal assessments in the months of April, June and August 2021. Youth Golf & Limited Time memberships are exempt from Capital Assessments for the 2020–2021 season.

Golf Season & Fiscal Year

Upon date of membership approval, access to the club will be granted. All memberships begin on the first day of our fiscal year October 1 and automatically renew on September 30 of each year. The new golf season starts on October 1 of each year and ends on September 30 of each year. If a member resigns on September 30, golf privileges will also cease on September 30. Once a member resigns from the club all access as a member will cease on the date of resignation.

Dependent Minors

Children under the age of 13 may play in the company of an adult at the Golf Professionals discretion, or, having completed the course readiness exam. If children 13 or under wish to play unaccompanied they must successfully pass the golf course readiness exam with one of the Golf Professionals on staff.

The age of the member October 1st will determine their membership classification for the golf season.

Members may add on a Practice Tee Membership. Please see Incidental Schedule.

Incomplete applications will not be accepted.

Application must include one (1) letter of sponsorship from current voting golf member, one (1) letter of personal reference, current dues payment and jpeg picture for member file. Initial dues payment is to be made by check or money order only and is required upon submitting an application for approval.
